ELIGIBILITY

A person may only get one additional entry, regardless of the number of people they tag. There is no purchase is necessary to enter.

PRIZING – SELECTED WINNERS

One winner will be chosen at random by the Franz Marketing Committee the week of December 18th, 2017 from among all the eligible entries received. Only one prize per person. The Administrator's decision is final and binding in all

matters. The winners will be notified via Direct Message on Instagram and will be asked to reply with their contact information to receive their prize by mail. The winner must claim their prize within 3 days of the time of notification or a secondary winner will be drawn.
